- Mr. McIntyre addressed concerns about ratepayers being muzzled at Board meetings citing Bylaw Bylaw #179.17,27, 28 and 29. He felt that ratepayers should be able to ask questions during a board meeting and that it is up to the Chairman to determine if a person is allowed to speak. Ratepayer Senta McIntyre also stated that information she was looking for was not on the website and if it was it was too difficult to locate.
- Rebuttal from Chairman Harold Walker included citing the updated Bylaw 208 where there were some slight variances. Mr. Walker stated that to maintain order at Board meetings, it would be good if ratepayers could limit the question period to 10 minutes as specified in the Bylaw. Mr. Walker apologized on behalf of the board and promised in future that we would try to do better.
