# Water Operators Report – Prepared by W. Settle

- Water samples have been good we did have a count in the water at the samples station on the highway but it was only 2 and IHA wasn't too worried about it, we resampled this last round of samples and it was 1 it is still really low and I didn't hear from IHA so we are still good
- We are still working with Western Water to help with costs and Ryan had got back the results of the filter testing that Dean and I did and they were really good
- We have been working on some of the valves for Beaver Falls Machine so I have some questions for Gary and hopefully he can shed some light on them there is a valve that is located by the creek it was not working so we dug it up and got it operating this one feeds the house and the cabin and on that note I am suggesting BFWD purchase a booster pump for this property under the contract we have in place for the people on Christie Rd as their water pressure is reading around 35psi depending on the level of the water in the tanks, also we found another valve that looks nothing like what

we have it is just a ball valve and it is located at the driveway entrance it also is not working but it is only partially turned off you can here is leaking by, it goes to an old house on the lower level of the property, the big issue is that the gas line goes right over top of it and there is a culvert and then it goes under the creek bed so the big question is what do you want to do with it and also it is not on the books as a tax or a toll, and then there is the valve for the shop that is all good

- I had a virtual meeting with WW Ryan and the Village of Fruitvale regarding the sewage lagoons and are they in compliance with IHA and what kind of testing do they do and how often
- IHA has been informed that we are putting in a chlorine pump and so we need to fill out a construction permit prior to installation. Pouria has sent me the permit application and I have filled it out and has sent it back.
- The next set of testing I will do a sample from above the lagoons and one below just to compare
