Tax Bylaw 2024

Ratepayers will notice that the 2024 Taxes have not increased. The budget for 2025 will be considering plans for future required improvements and ratepayers will notice an increase in 2025.

Taxes are collected to pay for capital expenditures such as new distribution systems, equipment purchases, and maintenance of the existing water system.

Payment Due on or before December 2, 2024

Payment Options

- Email Transfer use your PID# and ratepayer name in the message to ensure it is credited to the correct account.
- Cheque or Money Order. (We do not accept postdated cheques)
- Pay in person at Kootenay Savings Credit Union.
- Members of Kootenay Savings can pay Online, by phone, or in person.

*Remember to always include your PID number when making payment.

To avoid Penalties please allow sufficient time for your payment to reach us by the due date. Overdue accounts will be dealt with in accordance with District Bylaws and interest is applied quarterly on all accounts in arrears. DO YOU HAVE A Pressure Reducing Valve installed in your home?

In 2025 Beaverfalls Water Works District will be introducing a new Bylaw that will require all ratepayers to have a PRV or Pressure Reducing Valve installed in their residence. This is a building code requirement in all new builds. With so many changes in the weather, our water system has been experiencing more requirements to chlorinate because of coliforms and biofilms. This often requires us to use other water systems while we chlorinate. Get ahead of the problem by calling a plumber to install a PRV.
